Topic: Annual Business License Report

Date: 1/14/2025

HISTORY:

Please accept this memorandum as my annual report on the status of business licenses pursuant to #4-1-9-C1 of the Three Forks City Code. These numbers are current as of 1/8/2025.

The business license "season" runs from October 1st of one year to September 30th of the following year. As a policy, the City only lists businesses which are licensed with us on our website, as well as refer the businesses for anyone seeking a particular service/goods provider. The annual fee is \$50, or \$15 for a seasonal business. These may not be "brick and mortar" buildings here in town, but also those providing services/goods within the city limits.

REPORT:

For the 2023-2024 year, 228 businesses were licensed. Seasonal businesses ended up renewing prior to the end of the season. 10 of those were new for 2023-2024 (Exhibit A attached). 18 did not renew from the previous year due to a variety of reasons. 10 were sent to the Gallatin County Sheriff Office as "operating in violation without a license," but ultimately complied without citations issued. GCSO and City Attorney was used to intervene one business that was noncompliant. That business ultimately complied.

For the 2024-2025 season which began in October, there are a total of 216 businesses that have renewed or are new. 12 are new for this year (Exhibit B). 13 previously licensed businesses informed City Hall they would not be renewing due to a variety of reasons. Three reminder letters have now been sent, pursuant to #4-1-9-C2. 11 have not communicated with City Hall that they are no longer in operation so are assumed to still be in operation. These unlicensed businesses are listed in the attached Exhibit C. 7 are noted as "seasonal" which in my experience will renew prior to commencing business in whichever season they operate (Exhibit D).

Please see attached Exhibit C referencing those annual and seasonal businesses remaining to be licensed in order to comply with Ord. #4-1-9-C1.
